2. The following conditions should be mentioned in the promotion order issued by the appointing authority:-

- a) His promotion is purely provisional and;
- b) He will be liable for reversion –
 - i) If after review of the vacancies, it is found that his promotion is in excess of the vacancies available.

(Or)

- ii) If found unfit for retention in the post of Staff Car Driver, Grade-1.
- c) His promotion as Staff Car Driver, Grade-1 is subject to the outcome of any cases pending before the Hon'ble CAT and Hon'ble Courts.

- d) The attention of the promoted official is invited to the MHA's O.M. F.No. 7/1/80-Estt-P.1 dated 26/09/1981 and Ministry of Finance, Department of Expenditure (Implementation Cell) O.M. in F.No. 01/01/2008 regarding exercising of option for fixation of pay on promotion. Any further orders which Expenditure (Implementation Cell) O.M. in F.No. 01/01/2008 regarding exercising of option for fixation of pay on promotion. Any further orders which

may be passed by the Hon'ble Supreme Court, as per DOPT's OM in F.No.3602/11/2016-Estt[Res-I][Pt-II] dated 16-06-2018.

- e) His seniority in the cadre of Staff Car Driver, Grade-1 will be liable to revision at any point of time, if any bonafide mistake is found with reference to any records.
 - f) The official will not be eligible for pay fixation consequent to this promotion in case of his pay has already been upgraded in the scale of Staff Car Driver Grade-I under ACP/MACP Scheme.
3. The promotion order should be issued in the prescribed proforma immediately.
