- 2. It is observed with grave concern that the fund granted to DDOs under various heads is still not exhausted as on date. At some of the offices, bills are yet to be prepared and uploaded on the PFMS even after repeatedly informing that the end of financial year is approaching. There is huge amount of balance fund under the heads 'salaries' and 'wages' with most of the DDOs.
- 3. In view of the above, you are directed to adhere to following instructions.
  - (a) Bills for the balance fund under all the heads must be prepared and uploaded on PFMS and also submitted physically to ZAO/FPUs by 14/03/2022.
  - (b) The last batch of salary bills for the F.Y. 2021-22 are already processed. Hence, the fund under the 'salary' head must be kept only in case of pending applications for LTC. 'Wages' and 'RRT' bills for the month of February must be submitted to ZAO/FPU immediately.
  - (c) There may be a possibility of unutilized fund either due to no pending bills or due to bill amount in excess of the balance fund or due to any other circumstances. In all such cases, a surrender letter for unutilized portion of the fund with justification for the proposed surrender must be forward to ITO (Finance) office through e-mail at mail ID <a href="mailto:itofinsec@gmail.com">itofinsec@gmail.com</a> by 14/03/2022 and also inform telephonically.

- There have been instances where current-year outstanding bills have been 4. carried forward to the following year, affecting the projected expenditure for the following year too. Such a carry forward of pending bills to next year will not be accepted. It is also observed that the pending bills are not cleared despite the fact that there is balance fund available under specific object heads with some of the charges and DDOs are surrendering the amounts which is not acceptable and will be viewed adversely. DDOs must ensure that all pending bills must be attended and disposed off before 14.03.2022.
- It is also informed that to avoid last hour rush at ZAO office all the DDOS are directed to monitor the utilization of funds on day to day basis and clear the observations pertaining to processing of bills if any at the earliest so as to achieve 100% utilization of funds.
