- 2. The Election duty of **Shri Pradeep Kumar**, **ITI O/o Pr.CIT-1**, **Hyderabad**, is hereby cancelled due to his request on family grounds and in his place **Shri Srinivas Rao Inturi**, **O/o Pr.CCIT**, **Hyderabad** who is in reserve list, may be considered for election duty.
- 2.1 The Election duty of Shri P Akshat Reddy, , ITI O/o CIT (IT&TP), Hyderabad, is hereby cancelled due to his request on medical grounds and in his place Shri A Nagender, ITI O/o Pr.CIT (Central), Hyderabad who is in reserve list, may be considered for election duty.
- 3. All the Officers/officials mentioned at **Column No.2** are treated to be on deputation to the Investigation Wing from the date of this order to till the completion of the election process.

- 4. If leave has been granted already to the nominated Officers/officials, the same stand cancelled. Any leave required to be applied on the ground of emergency, the same is to be applied afresh to the District Supervising Officers {Addl./Jt. DsIT(Inv)}.
- 5. The District Supervising Officers {Addl./J.DIT(Inv)} will decide the granting of leave or permission to leave the station on merits and requirement of the Election Process.
- 6. All the officers/officials mentioned at Column No.2 are directed to attend to the capacity building programmes / election related meetings conducted by District Election Officer / Addl.DIT (Inv.), Nodal Officer (Elections), Unit-II, Hyd, whenever called till the election process is completed. Further, the Addl.DIT (Inv.), Nodal Officer (Elections), Unit-II, Hyderabad can depute the place of duty of officers/officials on duty, as per administrative requirements.
- 7. The nominated Officers/officials have to stay in the places assigned to them by Addl.DIT (Inv.), Nodal Officer (Elections), Unit-II, Hyderabad during the period i.e. from the date of this order till the completion of the election process. They have to report to the designated District Supervising Officers/Dist. Nodal Officers immediately.
- 8. Those who are deployed outstation, the TA/DA claims are to be made to the Investigation Directorate.
- 9. The nominated Officers/officials who are in "Assessment Circles/Wards and where there is no change of station" shall attend the election duty in addition to their regular work.
- 10. If any of the nominated Officers /officials close relative are contesting the Assembly Elections, the same need to be informed to the District Supervising Officers {Addl.DIT(Inv)} immediately.
- 11. This issues with the approval of the Pr. CCIT, Andhra Pradesh and Telangana.
