- 2. It is communicated to the HOO/AO/DDOs to complete the task of Scanning and uploading of written pages of Service Books along with their enclosures in respect of Group "A" Cadre, Group B cadre & Group C cadre in their office. Updation of leave and Leave Balance may also be uploaded in Leave Management Module in the HRMS, ITBA Portal. In this regard, information is sought by this office as per Annexure-I enclosed to this letter on or before 26.02.2021 positively.
- 3 The AO/DDOs are required to follow the provisions of SR199 and SR 202 related to nature of entries in Service Books and Periodical Inspection of Service Books by the Govt. Servant to avoid delay at the last hour.
- Further, It is informed that for Issue of service verification certificate on completion of qualifying service above 18 years, after 30 years and also 5 years before retirement of an employee may be done at DDO level as per the provision required in Form 24 (under Rule 32 of the CCS(Pension) Rules, 1972) and then forwarded to the Office of the Zonal Accounts Office, CBDT, Hyderabad or PAOs concerned for concurrence. The above instructions are to be followed scrupulously. The work may be supervised by HODs and a Compliance Report is to be sent by 05/03/2021.
