**MINUTES OF THE CGEWCC MEETING HELD ON 31.01.2020**

To consider "Ugadi" as a closed holiday, the meeting of Central Government Employees Welfare Co-ordination Committee, Telangana was held on 31.01.2020 at conference hall, 10-A, Income Tax Towers, AC Guards, Masab Tank, Hyderabad i.e, O/o. the Principal Chief Commissioner of Income Tax, Andhra Pradesh & Telangana. The meeting began at 11.30 AM with the welcome words by the Secretary Sri. M MOHAN BABU, IRS, Dy.CIT(HQ)(Admn), Hyderabad after a brief registration process. The items of agenda for the meeting were as under:

- (i) Observance of "Ugadi" festival as Closed Holiday.
- (ii) Observance of "Varalakshmi Vratham" festival as Restricted Holiday.

2. Welcoming the gathering, the Secretary Sri M MOHAN BABU, IRS, Dy. Commissioner of Income-tax(HQrs)(Admn, Hyderabad had given a brief introduction to all the members with regard to above points. He requested all the members to take up the discussion and stated that majority opinion may be considered as final decision. Members have welcomed the decision of the Secretary.

3. Earlier a meeting of CGEWCC was held on 10.10.2019 for the finalization of Closed & Restricted holidays to be observed in Telangana state for the calendar year 2020 and following three holidays were decided to be observed as compulsory closed holidays in addition to the 14 declared holidays by DoPT:

However, consequent to the representations received from Confederation of Central Government Employees & Workders (AP & TS unit) and from Ministry of Statistics & Programme Implementation, National statistical office (Field Operations Division), Hyderabad requesting to observe "Ugadi" festival as Closed Holiday and consider observation of " Varalakshmi Vratham" festival as Restricted Holiday, it is decided to conduct a meeting again to resolve the representations. In this background, in today's meeting all the members unanimously agreed to observe "Ugadi" festival as a Closed Holiday in place of "Mahashivaratri" underling the significance and scale of celebrations of "Ugadi" in the Telangana State.

5. It was also discussed to accommodate " Varalakshmi Vratham" festival in Restricted Holiday list, however the committee felt "Bathukamma / Dussehra" is State festival of Telangana and hence agreed to retain "Bathukamma / Dussehra" festival as a Restricted holiday. In view of this there is no change in the observance of Restricted Holiday as decided earlier.

In view of the above the CGEWCC, Telangana decided the following three holidays to be observed as compulsory closed holidays in addition to the 14 declared holiday by DoPT:

7. Finally, Sri. M MOHAN BABU, IRS, Dy.CIT(HQ)(Admn), Hyderabad & Secretary, CGEWCC, made his remarks and concluded the meeting.
