- 2. A training programme on OECD (GRTP) 'Advanced Seminar on Tax Treaties' is scheduled to be held at the National Academy of Direct Taxes (NADT), Nagpur from 10° to 14" June, 2019.
- 3. The Advanced Seminar on Tax Treaty Application will provide participants who have a reasonable understanding of the application of tax treaties with an opportunity to examine in detail the relatively complex tax treaty applications, its interpretation and policy issues. The discussions will include current treaty issues relating to the taxation of business profits, the permanent establishment definition, royalties, the taxation of foreign employees, treaty interpretation and countering treaty abuse, meaning of beneficial ownership and the application of the principal purpose general anti-avoidance test. The seminar will also discuss the multilateral instrument that India has signed to rapidly amend India's tax treaties.
- 4. The seminar is oriented towards the consideration of practical application issues through the discussion of case studies and selected Indian court cases. Accordingly, it will be useful for officers who are involved with the application and interpretation of tax treaties, consideration of competent authority issues and the negotiation of tax treaties.
- 5. It is therefore requested that officers of the rank of ACsIT to Pr. CsIT from International Taxation and the field formations may kindly be nominated for the same. At least four officers may kindly be nominated from Delhi, Mumbai, Chennai, Kolkata, Bengaluru, Hyderabad, Pune and Ahmedabad regions and three from other regions.
