To access the above said live classes the user has to install and login through Mobile Phone/Systems to attend the online Lectures. The Link & credentials for joining lecture and schedule for the courses will be shared through email or SMS or Whatsapp by the MSTU, Visakhapatnam.** The officials whose Email IDs/Mobile Nos are not displayed in the annexure shall contact the officials of MSTU, Visakhapatnam; Sri L.
