



The Addl. CsIT / JCsIT should prepare a **detailed Handing-Over Note** containing all the time-barring actions in the following areas of work whichever are applicable:

- (i) Scrutiny Assessments of all categories with date on which the assessment is getting barred by limitation(Time-barring date)
- (ii) Penalties of all categories
- (iii) Retention of books/documents
- (iv) Various Registers maintained in the respective Circle/Ward with status of updation
- (v) Survey Folders and status of submission of preliminary and final survey reports to higher authorities
- (vi) Dossier reports/folders
- (vii) RAP/IAP objections including status of remedial action
- (viii) Status of pending Scrutiny Reports on CIT(A)/ITAT/High Court orders
- (ix) Status of pending rectification applications and consequential orders
- (x) Status of pending grievances in E-nivaran and CPGRAMS
- (xi) Status of Action Plan Targets in respect of various areas of work as per Central Action Plan
- (xii) Report called for by the Pr.CCIT(vide letter dated 7.7.2020) with regard to Cases identified for Vivad-Se-Viswas Scheme.
