2. The above referred order is being passed in accordance with the recommendations of the Local Placement Committee.

3. The Pr.CsIT/Pr.DIT/DsIT/CsIT in consultation with their respective Pr.CCIT/CCIT/ DGIT, based on the territorial and functional requirements, may make additional charge arrangements within their jurisdiction, under intimation to this office.

4. The officers under orders of posting to O/o – DGIT(Inv), Hyderabad are hereby ordered to prepare a detailed handing over note at the time of handing over charge. Further, the officers whose charges have been merged into residual charges are also ordered to give a detailed handing over note at the time of relieving.

5. Officers whose names are mentioned in this order are required to submit the pendency of significant actions (as per template attached) and ensuring hand over of seized/impounded documents to the relevant Residuary officer for their erstwhile Circle before they relinquish their earlier charges.

6. The Pr.CsIT/Pr.DIT/DsIT/CsIT shall ensure that proper handing/taking over of records (as per template attached) is completed by 15-09-2020. A compliance report in this regard should be submitted to the O/o.Pr.CCIT, AP & TS, Hyderabad by 17-09-2020 positively.

7. All the above mentioned officers should be relieved by 15-09-2020 positively. The CCsIT, Pr.CsIT/Pr.DsIT/Addl.CsIT/JCsIT concerned are requested to ensure that the officers under order of transfer submit their self appraisal and/or report/review of APARs for the year 2019-20/part APAR for the current year before handing over the charge. The compliance report regarding relieving/joining of the above officers may be forwarded to the O/o.Pr.CCIT, AP & TS, Hyderabad by 17-09-2020 positively.

8. The officer under orders of transfer shall not be granted Earned Leave by the Competent Authority under whom they are presently working. Leave applications, if any, may be forwarded to the new place of posting for necessary action.

9. This order is issued with the prior approval of Pr.CCIT, AP & Telangana, Hyderabad.
