



Excel utilities for filing of Income Tax Returns ITR 1 and ITR 4 for AY 2023—24 have been deployed in the e-filing portal during the month of April 2023.

Demand Management

From the time of inception of Demand Management Facilitation Center till the end of 30th April 2023, an amount of 2,52,972 Crores have been reduced in 1,00,777 DINs.

Total Efforts on closing the demand:



During the month of April 2023, demand in 5,916 cases amounting to Rs. 25,150 Crores have been reduced. Major source of contribution for the closure of Demands is CPC/ITBA Demands which is 85% of overall demand closed. The region-wise break-up of the demands is as provided overleaf.

Interview of Late Shri C Aswath, eminent Kannada Music Composer by Ms Suprabha, ITO, CPC won the first prize in the literary category



Assessing Officer's Corner:

1.Path for legal heir addition in ITBA:

Jurisdictional/ Central/ International Taxation AOs can add legal heir, and not FAUs. Following is the overview of the steps to be followed by AOs for adding Legal Heir in ITBA:

ITBA Portal >> Common Functions >> Menu >> Legal Heir Details >> Enter PAN of the Deceased and tab out. Click on Search

If the legal heir details are available in the system, same will be displayed. Otherwise, a new Legal Heir will have to be added for the deceased PAN by clicking on Add Legal Heir >> Enter Date of death >> Enter Legal Heir PAN.

Based on PAN, Name and communication Address is displayed on screen >> Select Relation with Assessee >> Select Refund to be released to legal heir (Yes or No).



In case where **Refund to be released** is selected as **Yes**, the request will be submitted to **Range Head** for approval of legal heir addition request. If **Refund to be released** is **No**, it will not be
submitted to Range Head for approval. >> Click on **Save** button to save the details in the system
>> AO can add any supporting documents for the Legal Heir request >> In case where **Refund to be released** is **Yes**, User has to save Bank Details for the Legal Heir request.

In case where Refund to be released is No, Bank details are optional >> If the request has to go to Range for approval, Range User will be able to Approve, Reject or Send Back the request. In Range Head code, screen will be displayed in View Only mode for viewing the details for the Legal Heir request >> Once Legal Heir request is approved by Range Head, status of the Legal Heir in Legal Heir screen as seen by AO will be updated as Active.




2. Submission of response to outstanding demands by AO:

In order to submit response to outstanding demands, the AO is required to follow the following path: ITBA Portal -> Login -> Modules -> Recovery -> Menu -> Demand Analysis

Demand available on screen will be from 5 sources:

- CPC processed demand u/s 143(1) and consequential Rectification orders passed by CPC-ITR
- ITBA passed/processed 143(1), Assessment, Rectification, Give effect, Penalty orders
- Demand updated through Manual Order Upload functionality in ITBA
- Legacy AST passed orders after 01.04.2010. (Legacy demand before 01.04.2010 were required to be uploaded by AO in CPC-FAS)
- CPC- AO Demand Portal demand (Manually uploaded by AO).



i) Enter the search criteria and click on Search button.





- ii) Click on PAN hyperlink to navigate to Demand Analysis Details screen.
- iii) On click of PAN hyperlink user will be navigated to Analysis of a demand screen where AO will be able to select the demand and enter recoverability status for selected demand.
- iv) User selects the Demand and selects the Recoverability Status. Click on Enter Recoverability Details button and grid will open enter the relevant information based on selected recoverability status.
- v) Click on **Save** to save the Recoverability details and click on **Delete** to delete the details. By clicking on Save/delete the Amount difficult to recover will be updated accordingly.
- vi) Click on Submit to CPC to share the recoverability status with CPC.
