NOTIFICATION

Subject:- Notification of 'designated authority' under 'the Direct Tax Vivad Se Vishwas Act,2020' -reg.

In exercise of the powers under sub-section (1) and (2) of section 120 of the Income-tax Act, 1961 conferred upon me by the Government of India, Central Board of Direct taxes, New Delhi vide notification No.51/2014 in F.No. 187/35/2014-ITA-I dated 22nd October,2014 published in the Gazette of India, Extraordinary in Part-II Section 3, sub-section (ii) No.S.O.2753(E), I, the Principal Chief Commissioner of Income-tax, Andhra Pradesh & Telangana Region hereby notify that the following jurisdictional Principal Commissioners of Income-tax/Commissioners of Income-tax as specified in Column (2), having their headquarters at the place specified in the corresponding entries in Column (4) shall be the '**designated authorities**' under the Direct Tax Vivad Se Vishwas Act, 2020 (3 of 2020) (the Act) as defined in clause (e) of section 2 of the said act, which provides to the 'declarant' a mechanism to resolve disputes under the Income-tax Act, 1961 in respect of the 'declarant' over whom their jurisdiction is exercised.
