The officers/officials as per the **Annexure** are hereby nominated for the above mentioned **online course** to be held on **26.05.2020 to 29.05.2020**.

2. In view of the present restrictions to contain the spread of COVID-19 and under the directions of NADT, Nagpur, **the course is planned to be conducted through online mode via Cisco Webex Meeting Apps** (Cisco Systems, Inc.). Two sessions per day will be taken up covering two hours duration with a break of 30 minutes between the sessions.

3. The main objective of this course is to update the knowledge of the particulars with respect to provisions involved in taxation of income of Charitable Trusts. Emphasis is placed on the following issues:

- Objectives of the Trust
- Income of the Trust
- Application and accumulation of income
- Forfeiture of Exemption
- Search & Survey of Trusts
- Framing Assessments
- Contentious issues with recent case laws


4. The platform being used for delivery of live online classes is **Cisco Webex Meeting** (Cisco Systems, Inc.), which is available in Google Play Store & App Store of Apple products in mobile phones. The application is compatible with both Windows (Windows 10 and above) and iOS platforms. To access the above said live classes, the user has to install and log-in through mobile phone / computer system to attend the online lectures. The link and credentials for joining lectures and schedule for course being conducted will periodically be shared with the officials through Whatsapp or sms or mail in advance from DTRTI, Bangalore.

5. Training for better delivery is a huge challenge in contemporary times. For the department of Income Tax, its sole and most significant asset is manpower and accordingly, equipping government personnel with necessary skills is of utmost importance. **Thus, the Heads of Office concerned are directed to ensure that the nominated officers/officials to attend the training through online without fail. Since this is online course, no requests for exemption to attend the training course shall be considered.**


