

2. The following conditions should be mentioned in the promotion order to be issued by the appointing authority:
- c) His / her promotions are purely provisional
 - d) He /she will be liable for reversion,
 - i) If on a review of the vacancies, it is found that his / her promotion is in excess of the vacancies available;
 - ii) If found unfit for retention in the post of Administrative Officer, Grade-III (Group 'B' Gazetted).
 - c) his / her promotion/appointment as Administrative Officer (Grade-III) (Group 'B' Gazetted) is subject to the outcome of Hon'ble CAT / Hon'ble Court's Order, if any.
 - d) his / her attention is invited to MHA's O.M. in F.No.7/1/80-Estt.P.I dated 26.09.1981 read with CCS (Revised) Pay Rules, 2008 regarding exercising of option for fixation of pay on regular promotion.
 - e) his / her seniority in the cadre of Administrative Officer (Grade-III) (Group 'B' Gazetted) will be liable for revision at any point of time if any bonafide mistake is found with reference to any records.

- f) The official will not be eligible for pay fixation consequent on this promotion, if his / her pay has already been upgraded in the scale of Administrative Officer (Grade-III) (Group 'B' Gazetted) under ACP/MACP Scheme.
