(v) CBDT's letter in F.No.A-35015/26/2018-Ad. VI, dated 27.05.2019.

e) The promotions will be subject to the directions/clarifications issued by the Board/DOPT, in connection with the following OMs and any other OMs relating to the subject matter (i) DOPT's O.M. No.36012/2/96-Estt(Res.) dated 2/7/1997, (ii) DOPT's OM No.36028/17/2001/Estt(Res.) dated 24/7/2007 (iii) DOPT's O.M. No.36012/11/2016-Estt(Res.) dated 30/9/2016 (iv) DOPT's O.M. No.13013/2/2016-Ad.III dated 18/8/02017 (v) any further orders which may be passed by the Hon'ble Supreme Court, as per DOPT's O.M. No.36012/2/96-Estt(Res.)(Pt.II) dated 15/6/2018 (vi) CBDT letter in F.No.A-35015-26/2018-Ad.VI dt.27/05/2019, 20.02.2020, 12.02.2021 & 26.10.2021. (vii) DOPT OM No.20011/2/2019-Estt(D) dt.13.08.2021.
