

Subject. Prior permission of CCA before applying against open or public advertisement of vacancies by the International Organization, etc. -reg.

Kindly refer to above mentioned subject.

- In this regard, I am directed to state that instances have been noticed where officers have applied for deputation against open or public advertisement of vacancies by the International Organization and Foreign Governments without seeking prior permission for the same. I am directed to refer to Para 8.11 of DoP&T OM No. F.18/10/91-FA (UN) dated 20.06.1991 and DoP&T OM No. A13-14017/2/07-Estt (RR) dated 29.02.2008 and the extant guidelines of the DoP&T in this regard. The guidelines state as follows:
  - The officers may apply in response to the open or public advertisement of vacancies by the International Organizations and Foreign Governments with the prior permission of the Cadre Controlling Authorities concerned. In rare cases, when the time available for submitting the application is short, an officer may send his application to the concerned agency in advance with a copy to his cadre controlling authority and this may be confirmed or withdrawn subsequently depending of the authority.
  - The applicant officer shall be eligible for Foreign Service only after he has completed 9 years of service.

In this context. I am directed to convey that the officer should mandatorily seek prior permission before applying to the above-mentioned posts and only in rare cases, when time available for submitting the application is short, an officer may send his/her application to the concerned agency in advance with a copy to the Cadre Controlling Authority which is further subjected to decision of the Cadre Controlling Authority. The officer may also furnish the reasons for not seeking prior permission along with the intimation.

3. In view of the above, the undersigned is directed to request you to kindly bring the aforesaid instructions to the attention of all the officers posted in your/region, for applying against the open or public advertisement of vacancies by the International Organizations and foreign Governments. The advance copy of the requisite application in this regard may be sent to the Directorate of IIRD on <a href="mailto:cmdhrd/a incometax.gov.in">cmdhrd/a incometax.gov.in</a> before the due date for applying to the concerned International Organization along with the prescribed proforma (Annexure A), so that prior permission of the Cadre Controlling Authority may be sought within time. Further, the application of the officer may be confirmed or withdrawn subsequently by the officer concerned, depending upon the decision taken by the Cadre Controlling Authority.
