The CBDT Sports and Cultural Committee (CBDT SCC) has decided to conduct CBDT Table Tennis Tournament at Bengaluru on 15.12.2023 and 16.12.2023. The event is being conducted in order to showcase the rich and varied talent pool of the Department to encourage the spirit of camaraderie amongst the members of the Aayakar Parivar.

- 2. All Employees of Income Tax Department working in various offices falling under AP& TS may take part through sending the entries to represent the region AP & TS. In this connection, offices of IT departments may nominate their players for sending the entries, who are willing and whose services can be spared to participate in the above tournament.
- 3. Players are requested to send their entries through <u>email:</u> <u>hyderabad.ito.hq.welfare@incometax.gov.in</u> on or before 27.11.2023. However, names of officers and officials who are recruited in sports quota for Table Tennis are not to participate. Following are the details of the Tournament:

### RULES OF THE EVENT

(TABLE TENNIS)

#### > CATEGORIES:

The Table Tennis matches shall be conducted in the following categories:

INCLUSIONS & EXCLUSIONS: Officers/officials on deputation are eligible to participate. Their entry may be from the CCA region in which they are on deputation. Players recruited under Sports quota for tennis are not allowed to participate considering that they get several other opportunities to play in professional tournaments. Retired/Superannuated Officers/officials are not allowed to participate.

#### > FORMAT:

The matches will be played over 2 days - 15th & 16th December, 2023. Format for all the matches shall be best of 5/7 gan.es.

## > LIMITATION ON PARTICIPATION:

Each participant can participate in not more than two events. Any entry received without the recommendation of Cadre Controlling Authority, will not be considered.

#### TEAM STRENGTH: A

Each CCA region/Pr. DGIT (NADT), Nagpur shall nominate not more than 8 players (including those on deputation). With respect to Delhi region and Mumbai region, the number of nominations shall not exceed 12 (including those in Directorates/deputation) 1 Besides the participating players, each team may have one Coach / Manager. The filled form, in the case of Doubles/Mixed Double event, should clearly specify the name of the double's partners. The name of the partners will not be allowed to be changed once the entry form has been received by the organizing committee.
