- 2. Training for better delivery is a huge challenge in contemporary times. For the department of Income Tax, its sole and most significant asset is manpower and accordingly, equipping government personnel with necessary skills is utmost importance. Thus, the Heads of Office concerned are directed to relieve the officers so as to enable them to attend the training.
- 3. In view of the present restrictions to contain Covid-19, the course is planned to be conducted by NADT, Nagpur through online mode. Online Course and the link, credentials and other technical details for joining and schedule for sessions being conducted will periodically be shared with the officers through whatsapp or SMS or mail in advance by NADT, Nagpur.
- 4. The Prinicipal Chief Commissioner of Income Tax (CCA) desires that the officers sponsored for training should not apply for leave during this period. If any of the officer has already applied for leave, he/she should suitably revise the period of leave so that he / she can attend the training. Attending the training is obligatory and absence there from will be treated as dreliction of duty.
- 5. Even if any of the officer is under orders of transfer from the present office, or any particular officer has not reported for duty at the place of posting, he/she should invariably attend the training course.
- 6. The Course schedule and other instructions regarding the online course will also be updated by NADT, Nagpur.
- 7. As the Course is being conducted through the online mode, no exemption will be given for the concerned Officers. The absence to the said training will be viewed seriously.
