2. In continuation to the points highlighted in the video conference, it is stated that CsIT(Admin) of the respective region may be encouraged to create/develop content for Nukkad Natak and Mono Acting in English, Hindi and regional languages. Nukkad Natak and Mono Acting content that is created in Hindi and English languages and finalized by the regional offices may be forwarded to this Directorate. "Taxpayers - the driving force of civilization" or,

"India's growth story through the perspective of taxation"

3. In addition to the above, regions are encouraged to conduct relay-cyclothon covering important cities and towns of the respective states. The cyclothon may be attended by taxpayers, professionals, citizens and employees of the Department. Certain experienced cyclists from within the Department or otherwise may continue to cycle for the entire journey and some participants would join the rally at each important town/city. This would symbolically carry the message around the entire geography of the state spreading awareness about the event.



Dear Pt. Chief Commissioner of Income Tax,

Subject: Activities for Commemoration of 75 years of Independence (Bharat ka Amrit Mahotsav)-reg.

It may be kindly recalled that the 75th Anniversary of India's Independence will fall on 15th August, 2022. To commemorate the occasion, the PMO has encouraged ministries/departments to take possible innovative steps to mark the 75th year of Indian Independence.

2. In this background, the Cabinet Secretary has emphasized the main aspects of the commemoration as follows-

- a. While events will be organized for 75 weeks, that is, upto 15th August 2022, scheduling may be done by departments. A calendar of events needs to be prepared.
- b. Activities should be planned at different places of the country, involving public in general, (Jan-andolan)
- c. Achievements in the last 75 years and aspiration for India at 2047 both need to be presented.

3. You are requested to formulate a calendar of events for the 75th year of Independence within the guidance provided by the Cabinet Secretary. The activities must be conducted once in a quarter and details uploaded as per proforma given below on the google drive link of the department (<https://drive.google.com/drive/folders/1oWqj9zPG5rxE7dynaYnZ8ldsg06ZauN?usp=sharing>)

- b. Cultural programmes(once every 3 months)
- c. Designing, creation and display of Poster/Banners
- d. Plantation Drives/Cleaning Drives – In line with Swachh Bharat(once every 3 months)
- e. Hosting of talks/scrums by inviting regional luminaries and professionals from sports/academia/industry/culture/arts to discuss issues pertaining to taxation/economy and the future of the taxation ecosystem (once every 3 months)
- f. State level competition among school/college students on topics pertaining to taxation (once every quarter)
- g. Exhibitions for taxpayers (to be updated once every 6 month atleast), same could be mobile within the charge.
- h. Nukkad Natak (once every 3 months)
- i. Pr.CCITs(CCA) to create a grievance cell which will see to it that the timeline of taxpayer charter for disposal of grievances is not exceeded and/or the grievance is disposed off within one month. Timelines under taxpayer charter are being separately notified.
6. Considering the fact that the 75th Anniversary of India's independence will fall on 15th August 2022, in the weeks between 24th July, 2022 & 15th August, 2022, a gala event is proposed to be organized in Delhi to felicitate and showcase the best Nukkad Natak, Exhibition, Cultural Program, Poster/Banner from across the country.

7. In this background, it is requested that the calendar of events as finalized by you alongwith suggestions for the same if any, may be forwarded to Pr.DGIT(Admin. & TPS) at the earliest, positively by 23rd April, 2021 for overall co-ordination and reporting of the same within the Ministry of Finance.
