- 2. In view of the forthcoming General Elections to the Legislative Assembly of Telangana State, 2023, the Pr.CCIT AP&TS, Hyderabad vide Office Order cited in reference above has allotted man power to the Nodal Officer (Elections) i.e. Addl.DIT(Inv.), Unit-II, Hyderabad for carrying out the works related to Election Expenditure Monitoring. It may be noted that as per statute, we are obliged to provide requisite number of officers/officials to the Election Commission of India to do Election Expenditure Monitoring work.
- 3. The Commission expects all officials engaged in the conduct of elections to discharge their duties in an impartial manner without any fear or favour. They are deemed to be on deputation to the Commission and shall be subject to its control, supervision and discipline. The conduct of all Government officials who have been entrusted with election related responsibilities and duties would remain under constant scrutiny of the Commission and strict action shall be taken against those officials who are found wanting on any account.
- 4. In view of the constitutional duty related to Election Expenditure Monitoring and considering the quantum of expected workload during the elections, it is hereby directed that the Leave Application of the District Nodal Officers (DNOs) and ITIs allotted can only be considered in case of only extreme pressing grounds.

In view of the same, it is hereby instructed that officers and officials allotted, 5. shall adhere to strict discipline in applying for leave only in extreme exigency.
