विषय/Sub: Selection of an Additional Expert for the Tax Inspector Without Border (TIWB) programme for Criminal Investigation in Kenya – reg.

The undersigned is directed to invite applications from eligible officers from the Income Tax Department, Govt. of India, for the aforesaid programme.

- Applications are invited for selecting one officer for Kenya, along with one officer to be kept as reserve candidate, from the officers in the Rank of Addl. CIT/ Addl. DIT with minimum 10 years of experience with sufficient experience in investigation. The TIWB-CI programme is focused on untaxed economic activity, including illicit financial flows and aims to enhance tax crime investigation capability in developing countries. The essential component of this programme is indicated to be - (1) real-time hands-on investigation support, (2) bringing about systematic changes, (3) emphasis on "whole of government" approach, (4) using a diagnostic self-assessment tool, and (5) collaboration with other international agencies. The officer should also have at least 5 years of service left before his/her superannuation, as on the date of his/her selection by the Internal Committee.
- The officers will be providing help to investigators from Kenya Revenue Service 3. (KRA) in solving cases on real time basis & also expected to help KRA in its capacity building efforts. The officer shall be providing assistance to Kenya based in India only with few official tours/ visits to the country as per its requirement.
- The UNDP would finance the payment of Per Diem (at UNDP rates) and purchase economy class flights to attend agreed missions, subject to production of agreed work plan.
- The willing officers are requested to submit their applications with their resume, 5. including a brief write-up on their eligibility/ suitability for the above programme along

with a copy of IPR for the year 2023 and APAR grading summary for the last 05 years (R.Y. 2016-17 to 2021-22), through proper channel on or before 10<sup>th</sup> May, 2023 through IDeAS (IRS Deputation e-Application System). Eligible lady officers are strongly encouraged to apply.

- 6. This may be circulated among the eligible officers and the application should be forwarded to this Directorate on or before 10<sup>th</sup> May, 2023 positively.
