Procedure for Officers for sending articles for Taxalogue.

The article(s) can be sent on the email id: taxalogue@incometax.gov.in

The author while sending the article through e-mail may provide executive summary and few lines about him/her.

The author while sending the article through e-mail should provide the following disclaimer:

"This is to certify that the reported work submitted by me for publication in Taxalogue is an original work and has not been published elsewhere. I further certify that proper citations to the previous reported work have been given and no data/tables/figures have been quoted verbatim from other publications without giving due acknowledgement and without the permission of the original author(s)."

The Author may send the soft copy of passport sized photo while submitting the article via e-mail.

Proposed Structure of an Article

An article may be structured in following format:

Title: Compose a title that is simple, attractive and reflects the contents of the Article.

Header: no header should be used as header will be auto populated by the system.

Footer: footers may be used for noting references related to same page. For referencing, standard numerals in italics may be used within the text.

Abstract/Summary: A summary/abstract of the article may be given in the beginning which should not be more than 100 words.

Introduction: It is expected that writers will provide introduction to their article before moving into the main contents. Introduction may contain the discussed issue with it's background.

Acknowledgments/References: Acknowledgements/References (if any) may please be given at the end of the article.
