2. Training for better delivery is a huge challenge in contemporary times. For the department of Income Tax, its sole and most significant asset is manpower and accordingly, equipping government personnel with necessary skills is utmost importance. Thus, the Heads of Office concerned are directed to relieve the officials so as to enable them to attend the training.

In view of the present restrictions to contain the spread of COVID-19 and under the directions of NADT, Nagpur the DTRTI, Bengaluru planned the Online Course through **online mode i.e. Two sessions per day covering two hours duration with a break of 30 minutes between sessions. The platform being used for delivery of live online classes is Cisco Webex Meeting (Cisco Systems, Inc). The application is available in Google Play & App store of Apple Products in mobile phones. Both Windows and IOS platforms of desktops/ computer systems / tabs will support the application. The configuration of Windows 10 & above is compliance is compatible for running the application. To access the above said live classes, the user has to install & login through Mobile Phone / Computer Systems to attend the online lectures. The link & credentials for joining lectures and schedule for courses being conducted will be periodically shared with the officers / officials through Whatsapp or SMS or mail in advance by the DTRTI.**


4. The Principal Chief Commissioner of Income Tax (CCA) desires that the officers sponsored for training should not apply for leave during this period. If any of the officer has already applied for leave, he/she should suitably revise the period of leave so that he / she can attend the training. Attending the training is obligatory and absence there from will be treated as dereliction of duty.
