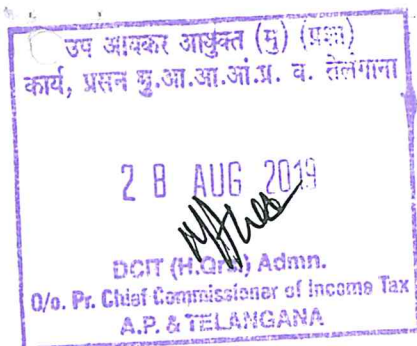

As you might be aware that the Department of Pension & Pensioners' Welfare has created a Dashboard on Department's Website i.e., www.doppw.gov.in. This Dashboard is being closely monitored both by the Prime Ministers' Office (PMO) and Hon'ble MOS(PP).

2. On the Dashboard, Bhavishya (an online pension sanction and payment tracking system) exhibits the pension cases of next 15 months under the category 'Cases on Time' as well as 'Cases Behind Schedule'. The details of the retiree is retrieved by Bhavishya from the EIS/PFMS system or salary package of your organization.

3. While going through the Dashboard it has been noticed that 1263 pension cases of Department of Revenue alongwith subordinate/attached officers are running behind schedule. The details of these cases alongwith DDO and PAO Code has been e-mailed at jsrev@nic.in for your kind perusal.

4. I shall be grateful if you could kindly direct the concerned officials to take time bound action to complete the process of sanction and payment of pension and other retirement dues of retiring employees.

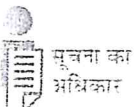
