
2. All the Officials mentioned in Annexure are treated to be on deputation to the Investigation Wing from the date to be notified later to till the completion of the election process.

3. If leave has been granted already to the nominated Officials, the same stand cancelled. Any leave required to be applied on the ground of emergency, the same is to be applied afresh to the District Supervising Officers {Addl./Jt. DsIT(Inv)}.

4. The District Supervising Officers {Addl./J.DIT(Inv)} will decide the granting of leave or permission to leave the station on merits and requirement of the Election Process.
5. All the officials mentioned above are directed to attend to the capacity building programmes / election related meetings conducted by District Election Officer / Addl.DIT (Inv.), Nodal Officer (Elections), Unit-II, Hyd, whenever called before Notification of Election. **Further, the Addl.DIT (Inv.), Nodal Officer (Elections), Unit-II, Hyderabad can depute the place of duty of officials on duty, as per administrative requirements.**
6. The nominated Officials have to stay in the places assigned to them by **Addl.DIT (Inv.), Nodal Officer (Elections), Unit-II, Hyderabad** during the period from **Notification Date till the completion of the election process.** They have to report to the designated District Supervising Officers/Dist. Nodal Officers in the forenoon of **Notification date.**
7. Those who are deployed outstation, the TA/DA claims are to be made to the Investigation Directorate.
8. The nominated ITIs who are in "Assessment Circles/Wards and where there is no change of station" shall attend the election duty in addition to their regular work.
10. If any of the nominated Officials close relative are contesting the Assembly Elections, the same need to be informed to the District Supervising Officers {Addl.DIT(Inv)} immediately.
11. This issues with the approval of the Pr. CCIT, Andhra Pradesh and Telangana.
