- 2. The following conditions should be mentioned in the promotion order to be issued by the appointing authority:-
  - a) His/her promotion is purely provisional and,
  - b) He/she will be liable for reversion -

if, after a review of the vacancies, it is found that his/her promotion is i. in excess of the vacancies available;

ii. if, found unfit for retention in the post of Senior Tax Assistant.

His/her promotion and seniority in the cadre of Senior Tax Assistant will be liable for revision at any point of time subject to seniority made in accordance with (i) O.A.No.598 of 2013 filed by Sri RSR Chandra Murthy and O.A.No.1325 of 2013 filed by Sri Manas Ranjan Behera filed before Hon'ble CAT (ii) Outcome of the OA No. 557 of 2014 filed by Sri G Maruthi Prasad and others before the Hon'ble CAT, Hyderabad Bench; (iii) Out come of any other cases pending before the Hon'ble CAT/other Courts, (iv) Any further orders which may be passed by the Hon'ble Supreme Court in DOP&T's O.M. in F.No.36012/11/2016-Estt.(Res-I) (Pt-II), Dated. 15.06.2018, (v) CBDT's letter in F.No.A-35015/26/2018-Ad. VI, Dated. 27.05.2019 & F.No.A -35015/26/2018-Ad.VI, Dated. 20.02.2020 and 12.02.2021, (vi) Outcome of Writ Petition(WPSR 57107/2022) pending before the Hon'ble High Court of Telangana (vii) O.A.No.788 of 2022 pending before Hon'ble CAT, Hyderabad Bench (viii) Outcome of decision to be taken by a larger bench of five Hon'ble Supreme Court Judges, as mentioned at para 35 of judgement dated 14.12.2022 by Hon'ble Supreme Court in the case of Hariharan and others Vs. Harshyardhan Singh Rao { SLP (c) No. 16161 of 2018}.

- c) The attention of the promoted official is invited to MHA's O.M. F. No.7/1/80-Estt-P.1 dated 26/09/1981 and Ministry of Finance, Department of Expenditure (Implementation Cell) O.M. in F.No.1/1/2008 & DOPT O.M no. 13/02/2017-Estt(Pay-I), dated. 27.07.2017 regarding Exercising of option for fixation of pay on promotion.
- d) His/her seniority in the cadre of Senior Tax Assistant will be liable for revision at any point of time if any bonafide mistake is found with reference to any records.
- e) His/her promotion is subject to outcome of recasting of reservation rosters in the cadre of in accordance with i) DOP&T's O.M. No. 36012/45/2005-Estt (Res.) dated 10.08.2010 & ii) DOP&T's O.M. in F.No.36012/11/2016-Estt.(Res-I) (Pt-II), Dated. 15.06.2018.
- g) His/ Her promotion will be subject to the directions / clarifications issued by the Board / DOPT in connection with the following OMs and any other OMs relating to the subject matter

- h) His/ Her promotion is subject to final outcome with regard to Board's letters in F.No. A-35015/26/2018-Ad.VI dated 27.05.2019 & A-35015/26/2018-Ad.VI dated 20.02.2020, 12/02/2021 & 26.10.2021.
- 3. If the pay of the official has already been upgraded under ACP / MACP scheme to the pay scale of Senior Tax Assistant then he/she will not be eligible for pay fixation consequent to this promotion.
- 4. The promotion order should be issued in the prescribed proforma, immediately.
- 5. The promotion to the cadre of Sr. Tax Assistant in respect of the above mentioned official is on in-situ basis and the place of posting of the above official will be reviewed in due course.
