CIT/ JCIT with minimum 3 years' relevant work experience in handling Common Reporting Standard (CRS) data, appropriate experience in Audit policy, practice and tax assessment, Data analytics, Treatment of CRS data, Compliance interventions, Risk assessments, use of CRS data. The officer should have left atleast 5 years of service left before his/her superannuation.

The officers will be expected to work very closely with Saint Lucia counterpart in 3. area of Automatic Exchange of Information (AEOI). The duration of the project is 12-18 months.
