ensuing Telangana State Assembly Elections-2018 - Reg.**

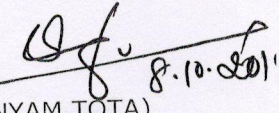
The Officers/Officials mentioned as per the Annexure of this letter are hereby nominated for election duty during the ensuing Telangana State Assembly Elections 2018.

2. All the Officers/Officials mentioned in Annexure are treated to be on deputation to the Investigation Wing from **08.10.2018 to 08.12.2018** or completion of the election process whichever is later.
3. If leave has been granted already to the nominated Officers/Officials, the same stand cancelled. Any leave required to be applied on the ground of emergency, the same is to be applied afresh to the District Supervising Officers {Addl./Jt. DsIT(Inv)}.
4. The District Supervising Officers {Addl./Jt. DsIT(Inv)} will decide the granting of leave or permission to leave the station on merits and requirement of the Election Process.
5. The nominated Officer/Officials have to stay in the places mentioned in this Order during the period from **08.10.2018 to 08.12.2018 (BDI) or completion of the election process whichever is later.** They have to report immediately to the nodal officer **Sri M. Satish, Addl DIT (Inv) Unit I, Hyderabad.**
6. Those who are deployed outstation, the TA/DA claims and other logistical requirements are to be made to the Investigation Directorate.
7. **All the officers ACsIT, ITOs who have been deputed for elections, have been designated as ADIT(OSD)(Inv) & ITO(OSD)(Inv) for all practical purposes.**
8. **The nominated ACsIT/ITOs/ITIs who are in "Assessment Circles/Wards and where there is no change of station" shall attend the election duty in addition to their regular work i.e., assessment work and other time barring matters if any.**
9. If any of the nominated Officers/Officials close relative are contesting the Assembly Elections, the same need to be informed to the District Supervising Officers {Addl./Jt. DCIT(Inv)} immediately.
10. This issues with the approval of the Pr. CCIT, Andhra Pradesh and Telangana.

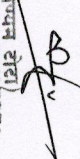

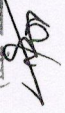
