The nominated officials stationed at Visakhapatnam are directed to attend the said course physically at MSTU, Visakhapatnam and the officials stationed outside Visakhapatnam may join the course online using MS Teams. Even, if **any of the officials is under the orders of transfer** from the present office, or any particular official has not reported for duty at the place of posting, he/she should invariably attend the training course.
