- 2. A training programme on OECD (GRTP) 'Advanced Seminar on Tax Treaties' is scheduled to be held at the National Academy of Direct Taxes (NADT), Nagpur from 22nd to 26th October, 2018.
- 3. The Advanced Seminar on Tax Treaty Application will provide participants who have a reasonable understanding of the application of tax treaties with an opportunity to examine in detail the relatively complex tax treaty applications, its interpretation and policy issues. Apart from covering the current treaty issues relating to the taxation of business profits and the work of OECD relating to base erosion and profit shifting (BEPS), the seminar will also bring in clarity on terms like Permanent Establishment, Royalties, Beneficial ownership and the application of the principal purpose general anti-avoidance test. The seminar will also take up issues regarding multilateral instrument that India has signed to rapidly amend India's tax treaties.
- 4. The seminar will therefore be useful for officials who are, or will be, involved with the application and interpretation of tax treaties, consideration of competent authority issues and the negotiation of tax treaties etc.
- 5.
