- 2. With regard to implementation of Hon'ble Central Administrative Tribunal, Pr. Bench, New Delhi order dated 01.06.2016 in OA No.1095/2014 in the case of K.P. Rajagopal and Ors Vs Union of India subject to outcome of W.P.No.3527/2019 filed by Union of India before Hon'ble High Court, New Delhi, the Zonal Accounts Officer, CBDT, Hyderabad vide letter dated 24.05.2023 emphasized for undertaking from the Pr. Chief Commissioner of Income Tax, AP & TS region for processing the bills pertaining to this region. Subsequently, at the request of this office, the Accounts Officer, LCS, O/o Pr. Chief Controller of Accounts, CBDT, New Delhi vide letter in F.No. PCCA/ CBDT/ Misc/Court/2022-23/264, dated 23.06.2023 has informed this office that, instructions/guidelines has been issued for passing of arrear bills.
