- 2. The following conditions should be mentioned in the promotion order to be issued by the appointing authority:
  - a) her promotions are purely provisional.
  - b) she will be liable for reversion.
    - i) If on a review of the vacancies, it is found that her promotion is in excess of the vacancies available.
    - ii) If found unfit for retention in the post of Administrative Officer Grade-II (Group 'B' Gazetted).
  - c) Her promotion/appointment as Administrative Officer (Grade-II) (Group 'B' Gazetted) is subject to the outcome of Hon'ble CAT/Hon'ble Court's Order, if any.
  - d) Her attention is invited to MHA's O.M. in F.No.7/1/80-Estt.P.I dated 26.09.1981 read with CCS (Revised) Pay Rules, 2008 regarding exercising of option for fixation of pay on regular promotion.
  - e) Her seniority in the cadre of Administrative Officer (Grade-II) (Group 'B' Gazetted) will be liable for revision at any point of time if any bonafide mistake is found with reference to any records.
