- Promotions to the cadre of Administrative Officer, Grade-III is on *in-situ* basis. These
 Officers shall continue to discharge the same functions as Office Superintendents in their
 respective Offices till further orders. The postings of Administrative Officers (Grade-III)
 will be reviewed in the AGT-2024.
- 3. The following conditions should be mentioned in the promotion order to be issued by the appointing authority mentioned at column no.3 above:
 - a) His promotion is purely provisional.
 - b) He will be liable for reversion.

i) If on a review of the vacancies, it is found that his promotion is in excess of the vacancies available.

ii) If found unfit for retention in the post of Administrative Officer, Grade-III (Group 'B' Gazetted).



- c) His promotion/appointment as Administrative Officer (Grade-III) (Group 'B' Gazetted) is subject to the outcome of Hon'ble CAT / Hon'ble Court's Order, if any.

- e) His seniority in the cadre of Administrative Officer (Grade-III) (Group 'B' Gazetted) will be liable for revision at any point of time if any bonafide mistake is found with reference to any records.
- f) The official will not be eligible for pay fixation consequent on this promotion, if his pay has already been upgraded in the scale of Administrative Officer (Grade-III) (Group 'B' Gazetted) under ACP/MACP Scheme.
