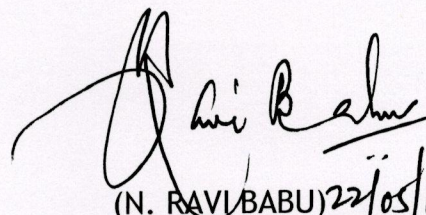

6. The Heads of Office are directed to send separate compliance report on relieving and joining of officials from/to their offices latest by **01.06.2018**, for updating the data in records. The Head of Office should certify in the compliance report that proper handing over note has been given to the successor at the time of relieving of official. It is also to be noted that the APARs of the officials reporting to the officers concerned are completed and duly forwarded.
