The undersigned is directed to invite applications from eligible officers of the Income Tax Department, Govt. of India, for the aforesaid programme.

- Applications are invited for selecting one officer for Azerbaijan, along with one officer as reserve candidate, from the officers in the Rank of Pr. CIT/ CIT/ Addl. CIT/ JCIT with minimum 10 years of relevant work experience in the field of Transfer Pricing (TP), higher education in tax/finance and international degree/certificates confirming the expertise in the field of transfer pricing and international taxation (ADIT, APCIT, etc.) along with rich experience in TP audit. The officer should have at least 5 years of service left before his/her superannuation.
- 3. The officers will be expected to work very closely with Azerbaijan counterpart in gathering/ analysing the information and reviewing the applicable laws related to Transfer Pricing Audit. The duration of the project is 12-18 months.
- 4. The UNDP would finance the payment of *Per Diem* (at UNDP rates) and purchase economy class flights to attend agreed missions, subject to production of agreed work plan.
