 - b) She will be liable for reversion.
 - i) If on a review of the vacancies, it is found that her promotion is in excess of the vacancies available.
 - ii) If found unfit for retention in the post of Private Secretary, (Group 'B'Gazetted, Ministerial)
 - c) Her promotion/appointment as Private Secretary, (Group 'B' Gazetted, Ministerial) is subject to the outcome of Hon'ble CAT / Hon'ble Court's Order, if any.
