and Rs.100/- pm against the ITEF(CHQ) proposals at Rs. 70/- & Rs.120/- pm from the salaries of the members of Group-C employees for the current **financial year: 2020-21** as per the Levels mentioned below :


1. For those employees who are upto Level-5 (MTS, Notice Servers, LDC, Tax Assistant, Steno Gr-II & III) : **Rs. 60/- pm**
2. For those employees who are in Level-6 (Office Superintendants, Sr.Tax Assistants, Steno Gr-I & Level-7 (ITI's)) : **Rs.100/- pm**

04. Further, it is submitted that there is no Group D cadre in the Central Government after 6th CPC and the Multi Tasking Staff (MTS) are to be considered as members of ITEF only. A resolution to this effect has already been passed and submitted to the CBDT by ITEF Central Headquarters vide letter dated 10.04.2020 (Copy enclosed). The DDOs may be directed to deduct annual subscription of ITEF from the May month salaries of MTS also (if not done so far in this year).

05. Hence, it is requested that necessary instructions may be issued to all the DDO's in Andhra Pradesh & Telangana Region to deduct the renewal fee by Monthly at given rates above (**renewal fee for the month of April, 2020 and May, 2020 to be deducted in the May, 2020 Salary**) from the members of Group-C employees for the current **Financial Year 2020-21** maintained with SYNDICATE BANK, Basheerbagh Branch, Hyderabad **A/c. no. 30042010033767**, MICR No. 500025011 and IFSC Code : SYNB: 0003004.
