 - (ii) if found unfit for retention in the post of Senior Tax Assistant
- c) their promotion as Senior Tax Assistant is subject to outcome of the decisions in various applications / petitions pending, if any, before CAT/Court, including writ petition in WP MP No. 40310 / 2010 in WP No. 31699/2010 pending before the Hon'ble High Court of Andhra Pradesh.
