

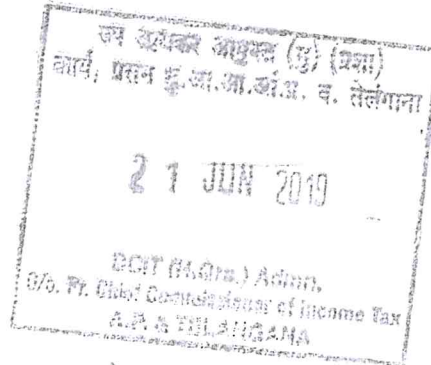
Sir,

Please refer the D.O. letter cited above regarding the redeployment of retired officials in the cadre of Stenographers/ Tax Assistant/ Income Tax Inspectors as an interim measure on contractual basis.

It is noticed that retired employees who are more than 65 years of age are also being engaged in different Offices viz Pr.CIT 7, Pr.CIT 3, Pr CIT 4, Pr CIT 2 even after completion of 10 years from the date of issue of the order, though the instructions were issued to engage them as an interim measure to tide over the shortage during that time.

It is therefore requested to review the position and revised guidelines may be obtained from the Board on the subject.

Sub: Re-deployment of retired officials of Income-tax Department - Reg.
Ref: Chairman, CBDT, New Delhi DO Letter No. 2352/CH(DT)/2008
Dated 18-08-2008 addressed to CCIT(CCA), Hyderabad.

Considering the shortage of staff in non-gazetted cadre, the Board vide its letter cited under reference, pending the process of direct recruitment, has granted approval for engaging retired officials in the cadre of Stenographers/Tax Assistants/Inspectors on contract basis as an interim measure. I am, therefore, directed to communicate the approval of CCIT(CCA), Hyderabad, for engaging retired officials in the cadre of Stenographers/Tax Assistants/Inspectors on contract basis subject to following conditions:-

- (a) They shall be paid a consolidated amount which will be last drawn gross emoluments less their pension. It is clarified that gross emoluments does not include HRA and Transport Allowance and pension means pension before commutation.
- (b) While engaging them no designation should be given and they should not be asked to discharge/exercise any statutory functions/powers.
- (c) It should be ensured that the work allotted to them shall not have any direct interaction with public.
- (d) They should not be deployed in the offices from where they retired.
- (e) A maximum of 4 persons can be redeployed in the entire CIT Charge. In case ITI/STA/TA they should be deployed only in the offices of CIT.

2. A draft contract to be entered with the redeployed official is enclosed for ready reference.
3. The expenditure shall be met from the OE allotted to the respective offices.
4. This office should be informed immediately after engaging the persons and copy of contract entered into should be sent to this office for record.

Sub: Redeployment of retired/retiring stenos, TAs and inspectors on contract basis – Implementation of the minutes of the 24th Conference of the CCsIT – req.

Please refer to the minutes of the 24th Conference of Chief Commissioners of Income Tax and Director General of Income Tax 2008 dated 2nd July 2008 wherein the matter regarding increasing work load and the manpower issues were discussed [Para 1(d) of page 7 refers]. The direction of the Finance Minister in this regard is quoted as under:

"To tide over the shortages, FM directed that, as an interim measure, the CCsIT (CCA) could re-employ Stenos, TAs and Inspectors who have recently retired/retiring pending the completion of process for direct recruitment in those categories."

2. You are therefore directed to take necessary action immediately and engage persons in the above categories on a **contract** basis.

Such person may be paid a consolidated amount which will be his last drawn gross emoluments less his pension.

4. A monthly compliance report in this case should be submitted to me indicating number of such persons engaged on contract basis. The performance is enclosed. Also send monthly report through the email address chairmancbdt@nic.in and ashok.sinha@nic.in.
