- Promotions to the cadre of Administrative Officer, Grade-III is on *in-situ* basis. These Officers shall continue to discharge the same functions as Office Superintendents in their respective Offices till further orders.
- The following conditions should be mentioned in the promotion order to be issued by the appointing authority mentioned at column no.3 above:
  - His/Her promotion is purely provisional.
  - He/She will be liable for reversion.
- If on a review of the vacancies, it is found that his/her promotion is in excess of the vacancies available.



- ii) If found unfit for retention in the post of Administrative Officer, Grade-III (Group 'B' Gazetted).
- c) His/Her promotion/appointment as Administrative Officer (Grade-III) (Group 'B' Gazetted) is subject to the outcome of Hon'ble CAT / Hon'ble Court's Order, if any.
- d) His/Her attention is invited to MHA's O.M. in F.No.7/1/80-Estt.P.I dated 26.09.1981 read with CCS (Revised) Pay Rules, 2016 regarding exercising of option for fixation of pay on regular promotion.
