2. The following conditions should be mentioned in the promotion order to be issued by the appointing authority mentioned at column no.3 above:

a) His promotion is purely provisional.

b) He will be liable for reversion.

i) If on a review of the vacancies, it is found that his promotion is in excess of the vacancies available.

ii) If found unfit for retention in the post of Administrative Officer, Grade-II (Group 'B' Gazetted).

c) His promotion/appointment as Administrative Officer (Grade-II) (Group 'B' Gazetted) is subject to the outcome of Hon'ble CAT / Hon'ble Court's Order, if any.
