2. The concerned CCIT/DGIT/PDIT/PCIT/CIT/DIT shall make necessary posting immediately in respect of all officials who are posted in their charge without changing the station, under intimation to this office.

3. The Heads of Office are required to relieve the officials under orders of transfer positively by **15.09.2026**.

4. The officials under orders of transfer shall not be granted Earned Leave by the Competent Authority under whom they are presently working. Leave applications, if any, may be forwarded to the new place of posting for necessary action.

5. In case, any official is being proposed to be retained beyond the above-mentioned date, the Head of office shall take prior written approval from the Pr.CCIT, AP & Telangana.
6. The Heads of Office are directed to send separate compliance reports on relieving and joining of officials from/to their offices latest by **18.09.2026** to the ITO(HQ)(Pers.)(OSD), O/o. PCCIT, AP & TG, Hyderabad.
7. Unless the transfer order is cancelled either suo-moto or on representation, before the due date of relieving the transferee shall be considered as deemed relieved on the due date given in the transfer order. It is clarified that representation made against the transfer shall not confer any right whatsoever on the official to continue at the previous post in defiance of the transfer order. In view of this, if any of the Official is not relieved by the due date, he/she shall be deemed relieved by the next working day.
8. All representations received are considered and stands disposed of.
9. This order is issued with the prior approval of the Pr.CCIT, AP & TG, Hyderabad.
