Sub: Offices to remain open on 22nd, 23rd, 29th, 30th & 31st March 2025 reg.

This is to bring to your kind notice that the Directorate of Expenditure Budget has moved proposals for re-appropriation of funds as per the requirement indicated by the BCAs in the Google Sheets, into the following Object Heads:

- Fuel & Lubricants
- Professional Services
- Repair & Maintenance
- Office Expenses

Due to the heavy workload in the Ministry, the approval is taking longer than usual, however, it is expected that approval should come by the end of the week.
