6. Officers whose names are mentioned in this order are required to submit the pendency of significant actions before they hand over / relinquish their earlier charges.
7. The officer under orders of transfer shall not be granted Earned Leave by the Competent Authority under whom they are presently working. Leave applications, if any, may be forwarded to the new place of posting for necessary action.
