- In case, any officer is being proposed to be retained beyond the above-mentioned date, the Head of office shall take prior written approval from the Pr.CCIT, AP & Telangana.
- The Heads of Offices are directed to send separate compliance report on relieving and joining of the officers from/to their offices latest by **02-07-2026** to the DCIT (HQ)(Admin), O/o.PCCIT, AP & TG, Hyderabad.

In view of this, if any of the Officers is not relieved by due date, he/she shall be deemed relieved by next working day.
