4. The concerned CCIT/DGIT/PDIT/CIT/DIT shall make necessary postings immediately in respect of officers posted to their charge without changing the station under intimation to this office. The additional charge arrangements in respect of vacant posts in their charge may also be made by the concerned PCsIT/CsIT wherever necessary, under intimation to this office.

5. No additional remuneration shall be admissible under FR-49(iii) to the officer(s) holding additional charge as per the above order.

6. All the Heads of Office are required to relieve the officers under order of transfer positively by **07-07-2026**.

7. The officers under order of transfer shall not be granted Earned Leave by the Competent Authority under whom they are presently working. Leave applications, if any, may be forwarded to the new place of posting for necessary action.

8. In case, any officer is being proposed to be retained beyond the above-mentioned date, the Head of office shall take prior written approval from the Pr.CCIT, AP & Telangana.

9. The Heads of Offices are directed to send separate compliance report on relieving and joining of the officers from/to their offices latest by **10-07-2026**, for updating the data in records. The Head of Office should certify in the compliance report that proper handing over note has been given to the successor at the time of relieving of officer. It is also to be noted that the APARs of the official reporting to the officers concerned are completed and duly forwarded.

10. Unless the transfer order is cancelled either *suo-moto* or on representation, before the due date of relieving, the transferee shall be considered as deemed relieved on the due date given in the transfer order. It is clarified that representation made against the transfer shall not confer any right whatsoever on the officer to continue at the previous post in defiance of the transfer order. In view of this, if any of the Officers is not relieved by due date, he/she shall be deemed relieved by next working day.

11. This order is issued with the prior approval of the Pr. Chief Commissioner of Income Tax, AP&TG, Hyderabad.
