records. The Head of Office should certify in the compliance report that proper handing over note has been given to the successor at the time of relieving of officer. It is also to be noted that the APARs of the official reporting to the officers concerned are completed and duly forwarded.

11. Unless the transfer order is cancelled either *suo-moto* or on representation, before the due date of relieving, the transferee shall be considered as deemed relieved on the due date given in the transfer order. It is clarified that representation made against the transfer shall not confer any right whatsoever on the officer to continue at the previous post in defiance of the transfer order. In view of this, if any of the Officers is not relieved by due date, he/she shall be deemed relieved by next working day.

12. This order is issued with the prior approval of the Pr. Chief Commissioner of Income Tax, AP&TG, Hyderabad.
