



4. No additional remuneration shall be admissible under FR-49(iii) to the officer(s) holding additional charge as per the above order.
5. The Heads of Office are required to relieve the officers under orders of transfer positively by **07-08-2026**.
6. The officers under order of transfer shall not be granted Earned Leave by the Competent Authority under whom they are presently working. Leave applications, if any, may be forwarded to the new place of posting for necessary action.
7. In case, any officer is being proposed to be retained beyond the above-mentioned date, the Head of office shall take prior written approval from the Pr.CCIT, AP & Telangana.
8. The Heads of Offices are directed to send separate compliance report on relieving and joining of the officers from/to their offices latest by **11-08-2026** to the DCIT (HQ)(Admin), O/o PCCIT, AP & TG, Hyderabad.
9. Unless the transfer order is cancelled either suo-moto or on representation, before the due date of relieving the transferee shall be considered as deemed relieved on the due date given in the transfer order. It is clarified that representation made against the transfer shall not confer any right whatsoever on the officer to continue at the previous post in defiance of the transfer order. In view of this, if any of the Officers is not relieved by due date, he/she shall be deemed relieved by next working day.
10. All representations received are considered and stands disposed off with this order.
11. This order is issued with the prior approval of the Pr. CCIT, AP & TG, Hyderabad.
