- Promotions to the cadre of Administrative Officer, Grade-III is on *in-situ* basis. The Officer shall continue to discharge the same functions as Office Superintendent in his respective Office till further orders.
- The following conditions should be mentioned in the promotion order to be issued by the appointing authority mentioned at column no.3 above:
 - His/her promotion is purely provisional.
 - He/she will be liable for reversion.
 - If on a review of the vacancies, it is found that his/her promotion is in excess of the vacancies available.
 - If found unfit for retention in the post of Administrative Officer, Grade-III (Group 'B' Gazetted).
