2. The respective Controlling Authority, under whose charge the officers are presently posted shall issue the promotion order immediately and endorse a copy thereof to this office. The date of joining of the Officers shall be intimated to this office by respective CCIT/DGIT/PCIT/PDIT/CIT/DIT by **02/07/2026**.
3. Promotions to the cadre of Administrative Officer, Grade-II is on *in-situ* basis. These Officers shall continue to discharge the same functions as Administrative Officer, Grade-III in their respective Offices till further orders.
4. The following conditions should be mentioned in the promotion order to be issued by the appointing authority mentioned at column no.3 above:
 - a) His promotion is purely provisional.
 - b) He will be liable for reversion.
 - i) If on a review of the vacancies, it is found that his promotion is in excess of the vacancies available.
 - ii) If found unfit for retention in the post of Administrative Officer, Grade-II (Group 'B' Gazetted).
 - c) His promotion/appointment as Administrative Officer (Grade-II) (Group 'B' Gazetted) is subject to the outcome of Hon'ble CAT / Hon'ble Courts Order, if any.
