Memorandum

Sub: Redeployment of Casual Workers paid under Wages Object Head in the CCA jurisdiction of Pr. CCIT, AP & Telangana Region – Ensuring Administrative Impartiality and Efficiency – Reg.

In partial modification to the Memorandum even number dated 30.03.2026, issued by the office of the Pr.CCIT, AP & TG, Hyderabad, the following Casual Workers paid under Wages are hereby redeployed to the specified offices with immediate effect, as detailed in the Annexure-1.

2. The AOs(DDO) and AOs(Estt) of all Heads of Department (HODs) are requested to implement the redeployments forthwith and ensure seamless transition without disruption to office functioning.

3. Compliance reports, confirming implementation, shall be submitted by all AOs(DDO)/AOs(Estt) to this office on or before 22.05.2026.

4. In this regard, it is clarified that payment under the “Wages” head does not confer any right or claim for absorption or regularization in Government service. Engagement of casual workers and payment of wages to them are governed strictly by the instructions issued by the Government of India, DoPT and CBDT and the judgment of the Hon’ble Supreme Court in the case of Secretary, State of Karnataka vs. Umadevi & Others.

5. This issues with the prior approval of the Pr. CCIT, AP & TG, Hyderabad.
